

# **County** 2024 La Porte County Draft Horse Show **Farm Classes Entry Form**

# September 5-6-7, 2024 at the La Porte County Fairgrounds

General rules/info:

- Upon arrival at the show you must check in at the office next to the draft horse arena for stall assignments (if available) and completion of paperwork.
- Check-in time for farm teams: before 3:00 pm Thursday or after 8:00 pm Thursday, or, before 8 am Friday or between noon-3pm Friday. If you are assigned to a stall you cannot unload by the arena and barns during show times.
- All show entries must have submitted this entry form to the show organizer.
- Exhibitors must have proof of health papers and negative test for Equine Infectious Anemia/EIS (COGGINS) conducted within one year of the date of the show.
- All adult class drivers must be at least 18 years of age and out of 4H to drive in men's or women's classes.
- All drivers under 18 years of age must have an experienced adult driver to accompany them in the ring.
- Only drivers and lineman are permitted on wagons in all events—absolutely no riders.
- The same horse may not be used in both the Men's and Ladies Cart Classes.
- The same horse may not be used on both Farm and Hitch Classes.
- No show harness or show wagons are allowed in a Farm Class.
- All horses must be at least 14 hands in height to compete in the show.
- Gate steward has final rule on safety as to who may enter the show arena.
- There are no refunds. The Judge's decision is final.
- Camping sites are available at the La Porte County Fairgrounds. Details will be posted.
- Stalls are assigned by the show organizers, and may not be available for farm class entries. It is anticipated that barns will be at capacity.
